Our effort is to provide every guest with a clean, healthy & safe environment that is free of disease, ticks and fleas. Therefore as part of the check in process every pet is carefully inspected for fleas, ticks, or obvious signs of ill health, they are also expected to be clean and free of bad odor. **If your dog has bad odor, a bath will be given upon arriving at our facility, the owner will be charged for this initial bath.** If your dog is found to have fleas or ticks, we require that he/she is treated before being placed in a suite. **THE FEE WILL BE A KENNEL BATH CHARGE (BASED ON THE SIZE OF DOG) PLUS \$20 FOR FLEA CONTROL**

marked with your pet's name (first & last) on the lid plus container. Please bring adequate food for the duration of your pet's visit. A \$5.00 per day per dog charge will be incurred if you do not bring dog food, or if your dog runs out of food during his/her stay.

This is an Agreement between Ms. C's Bed & Biscuits, LLC and the pet owner whose signature appears below (hereinafter called "Owner").

1. Owner specifically represents to Ms. C's Bed & Biscuits, LLC that, to Owner's knowledge, the pet has not been exposed to any contagious diseases within a thirty-day period prior to check in. During the period of this Agreement, Owner also agrees to notify Ms. C's Bed & Biscuits, LLC of any known exposure of pet to a communicable disease and hold pet out of attending Ms. C's Bed & Biscuits, LLC until pet is symptom-free for a minimum of 14 days and has been released by a veterinarian to attend Ms C's Bed & Biscuits, LLC.
2. If your dog becomes ill or injured, or if the state of the animal's health otherwise requires professional attention, Ms. C's Bed & Biscuits, LLC, in its sole discretion, may engage in services of a veterinarian or administer medicine or give other requisite attention to the animal, and express thereof shall be paid by the Owner. Ms. C's Bed & Biscuits, LLC will engage in reasonable accommodations for assuring the pets' health and safety while in the custody of Ms. C's Bed & Biscuits, LLC.
3. For everyone's, (other canine guests included) safety, **dogs should be neutered/spayed to enter the facility.** If your dog is not neutered or spayed, causes any havoc in the facility, or comes in "heat" while at the facility, the Emergency Contact, listed on this agreement, will be called. The dog must be picked up immediately. Owner agrees, no female dog in heat will be accepted into the facility.
4. Pets who must be fed separately must reserve separate suites, paying for the number of suites used.
5. Ms. C's Bed & Biscuits, LLC shall exercise reasonable care for the pet delivered by the Owner to the pet care provider. If interactive play is provided, Owner recognizes and accepts potential risk involved in play activities. Owner recognizes and accepts the potential risk involved in boarding the owners pet. It is expressly agreed by Owner and pet care provider that Ms. C's Bed & Biscuits, LLC indebtedness shall in no event exceed the lesser of the current chattel value of a pet of the same species, or the maximum sum of \$500.00 per animal admitted by Owner. The Owner further agrees to be solely responsible for any and all acts or behavior of said pet while it is in the care of the pet care provider. Owner is responsible for payment of costs for injury to the owners pet, to the staff or other animals, or damages to the facilities caused by the Owner's pet.
6. Owner agrees to pay the rate for pet care provided in effect on the date pet is checked into Ms C's Bed & Biscuits, LLC. Boarding rates are per night. **Checks outs after 12:00 NOON will be charged daycare (\$20 per dog) the day of check out.**
7. By signing this Agreement and leaving pet with Ms. C's Bed & Biscuits, LLC Owner certifies to the accuracy of all information given about said pet. Ms. C's Bed & Biscuits, LLC reserves the right to deny admittance to Owner's pet for any reason at any time.
8. Owner specifically represents that he/she is the sole owner of the pet, free and clear of all liens and encumbrances.
9. Owner agrees to pay all costs and charges for special services requested, and all veterinary costs for the pet during the period said pet is in the care of Ms C's Bed & Biscuits, LLC. Owner further agrees to be financially responsible for any required treatment for fleas/ticks, if determined necessary by Ms. C's Bed & Biscuits, LLC.
10. Owner agrees that the pet shall not leave the facility until Owner pays all charges.
11. If the reservation is not cancelled within 48 hours (2 days) of scheduled arrival, the equivalent of one night's boarding stay will be charged to the credit card. For **Major Holidays WEEKS including** (Memorial Day, 4th of July, Labor Day, Thanksgiving, Christmas, and New Year's) and **Spring & Fall Break** Ms. C's Bed & Biscuits, LLC requires a one week (7 day) notice of cancellation, if the reservation is not cancelled within one week (7 days) of scheduled arrival, the equivalent of two night's boarding will be charged to owner's account or to the owner's credit card on account (discretion of Ms C's Bed & Biscuits, LLC). All reservations must be

guaranteed on a credit card.

12. If the pet is picked up from the kennel prior to the "reserved departure date" during a major holiday (listed in # 12), Spring or Fall Break, the charge for the stay will be the entire duration of the reserved dates. There will be no penalty if the reservation dates are not cancelled, but simply CHANGED with the same number of nights as the original reservation made (discretion of Ms C's Bed & Biscuits, LLC).
13. This Agreement contains agreement between the parties. All terms and conditions of this Agreement shall be binding on the heirs, administrators, personal representatives and assigns of the Owner and Ms. C's Bed & Biscuits, LLC.
14. All Charges incurred by Owner shall be payable upon pick up of pet. Ms C's Bed & Biscuits, LLC shall have and is hereby granted, a lien on the pet for any and all unpaid charges resulting from services provided by Ms. C's Bed & Biscuits, LLC. The Owner hereby agrees that in the event the charges are not paid when due in accordance with this agreement, Ms. C's Bed & Biscuits, LLC may exercise its lien rights, upon ten days written notice given by Ms. C's Bed & Biscuits, LLC to Owner by certified mail to address shown on this contract. Ms C's Bed & Biscuits, LLC may dispose of pet for any and all unpaid charges, at private or public sale, in the sole discretion of Ms C's Bed & Biscuits, LLC, and the Owner specifically waives all statutory or legal rights to the contrary. If such sale shall not secure a price adequate to pay such costs of pet care or other charges delinquent, plus costs of sale, then Owner shall be liable to Ms. C's Bed & Biscuits, LLC for the difference. All monies realized by Ms. C's Bed & Biscuits, LLC at such sale, over and above the charges due and costs of sale, shall be paid to the Owner by Ms. C's Bed & Biscuits, LLC.
15. Any controversy or claim arising out of or relating to this Agreement, or the breach, thereof, or as the result of any claims or controversy involving the alleged negligence by any party to this Agreement, shall be settled in accordance with the rules of the American Arbitration Association, and judgment upon the award rendered by an arbitrator may be entered in any Court having jurisdiction thereof. The arbitrator shall, as part of the award, determine an award to the prevailing part of the costs of such arbitration and reasonable attorney's fees of the prevailing party.
